Notice Pursuant To Section 177ae Of The Planning & Development Act 2000, As Amended, Relating To A Proposed Development By Meath County Council

TAKE NOTICE that Meath County Council proposes to seek approval from An Coimisiún Pleanála to carry out the following development:- **Newtownmoyaghy Road Improvement Scheme** in the townland of **Newtownmoyaghy, Kilcock, Co. Meath.**

The proposed development will consist of:

- Diversion of the Newtownmoyaghy Stream within an area of agricultural grassland to the northeast of the existing channel and road
- Piping, infilling and topsoiling of the existing stream channel
- Provision of new culvert under the Newtownmoyaghy Road to connect the diverted stream into the existing channel downstream
- Provision of agricultural crossings over the new channel
- Widening of the existing carriageway
- Construction of new road pavement and upgrade of existing road pavement
- Alterations to the entrance of one residential property
- Provision of new agricultural entrances and
- Provision of associated drainage infrastructure, boundary treatments, surfacing works, road marking, traffic signage and landscaping.

A Natura Impact Statement (NIS) has been prepared in respect of the proposed development.

An Coimisiún Pleanála may approve the proposed development in whole or in part, with or without specified modifications or it may refuse to approve the proposed development.

Extension of Temporary Closure of L-28142-1 Pitcher Lane, Kells, Co Meath

Meath County Council has made an order to extend the temporary road closure on L-28142-1 Pitcher Lane, Kells, Co Meath, from its junction with R-147-40 Carrick Street to its junction with L-2814-2 Willie Black Crescent.

The closure was due to end at 6pm on Friday, 3 October 2025 and will now be extended to 6pm on Friday, 10 October 2025.

This road closure is required to facilitate Uisce Éireann drinking water and sewer connection for Meath County Council Housing.

Alternative Routes

Via R-147 Carrick Street, R-164 Oliver Plunkett Road and L-28142 Colmcille's Villas.

Diversion and information signage will be in place. Access for residents and property holders will be facilitated throughout the closure period.

Temporary Closure of L-10073, Cheeverstown, Fidorfe, Kilrue, Harlockstown, Co Meath

Proposed Temporary Closure of L-4022-0, Kildalkey Road, Trim, Co Meath
